

For Cannabinoid analysis, only delta 9-THC, THCA, CBD, CBDA are ORELAP accredited analytes. Cannabinoid values reported for plant matter are dry weight corrected; Oregon Water Activity action level is 0.65Aw and Oregon Moisture Content action level is 15%, Samples above limit will be highlighted RED; FD = Field Duplicate; LOQ = Limit of Quantitation.


